Trinidad and Tobago COVID-19 (Novel Coronavirus) Update # 430

Port-of-Spain, August 31st 2020: As part of the national drive to safeguard the health of the Trinidad and Tobago population in the face of the global COVID-19 outbreak, the Ministry of Health continues to provide up-to-date information on the country's status in this regard.

The population is reminded to source your information only from official sources, such as the Ministry of Health.

The Ministry of Health provides the following clinical update as of the **morning** of **Monday 31**st **August**, **2020**:

Number of samples submitted to the Caribbean Public	23,530
Health Agency (CARPHA), the UWI and other local sites for testing for COVID-19.	
Number of unique patient tests completed	20,608
Number of repeated tests	2,922
Number of samples which have tested positive at public and private facilities in Trinidad and Tobago	1,727
Total number of active cases	1,029
Number of deaths	22
Number of persons discharged	676

The thirty-six (36) positive cases reported below show results from samples taken during the period August 23rd to August 29th, 2020. Therefore, this figure is NOT representative of the positive cases over the last 24 hours only.









The Ministry of Health provides the following update:

The Ministry of Health regrets to inform the public that there is an additional COVID-19 related death. The person is an elderly female with co-morbidities. This brings the total number of COVID-19 related deaths to 22.

- Thirty-six (36) additional persons have tested positive for COVID -19.
- Four (4) persons have been discharged.

COVID-19 Positive Patients in Hospital - (78)

Nine hundred and nine (909) patients are in home isolation under the continuous monitoring of the respective County Medical Officer Health (CMOH) offices. Thirty-six (36) new patients will be processed for admission at the discretion of the CMOHs.

Intensive Care Units (ICUs) are hospital wards that provide treatment for people who are very ill. They are staffed with health care professionals who are trained in ICU treatment and the use of sophisticated monitoring equipment.

High Dependency Units (HDUs) are wards for people who need more observation, treatment and nursing care than is possible in a general ward but slightly less than that given in an Intensive Care Unit.

An Ambulatory Patient is able to walk about and is not bedridden.
